South Carolina } Know all men by these presents that I William Robbs Senr of the Greenville District } Said State and district do hereby Grant Bargain Sell and release unto Hedgman Green a certain tract or parcel of land containing forty five acres be the same more or less for the sum of one hundred and fifty dollars paid to me in hand by the said Hedgman Green being a part of a tract of land originally granted to Daniel Woolbanks lying and being on the north side of South Syger River being a down- measured by Thomas P Hudson - Butting and bounding as is Represented in the plat having such courses as follows, Beginning on a willow Oak at the river Running thence N 6 E 22 Chains 40 links to and oak thence N 86 W 14 Chains 70 links to a Hickery thence South 44 W 14 Chains to the opposite side of the river to a gum thence the Meanders of the River to a Red oak thence the River to the Beginning having such marks and Boundaries as is Represented in the plat I the said William Robbs do hereby Grant Bargain Sell and deliver unto Hedgman Green and by these presents do hereby Warrant and forever defend all and singular from me my heirs Executors administrators or any other person or persons lawfully claiming the same or any part thereof to him the said Hedgman Green his heirs or assigns forever as Witness Whereof I hereby set my hand and seal this 15th January one thousand Eight hundred and twenty nine and being the fifty third year of the Independence of the united States of America Signed sealed & delivered John Mcmakin
