on the Waters of Reedy River containing one hundred and forty three acres  
be the Same more or less having such Boundaries as are hereunto annexed  
Beginning on Montgomerys Spring Branch Miles Gales line thence down Said  
Branch on Gales line to James Bennies line thence with James Bennie line  
up the old Bottom to Where Said Bennie line will Run crossing a branch  
and down with Said Branch with Said Bennies to Said Gales line to the old  
original line thence No. 60 E. to alightwood Stake corner thence No. 30 D. W.  
44. 72 crossing the forks of Reedy River to Red oak corner thence S. 60 W  
to the Beginning corner on Said Montgomerys Branch to have and to hold  
all the Said premises unto the Said Sourdain Batson his heirs and assigns for  
Ever, and I do hereby Bind myself my heirs Executors and administrators  
to Warrant and forever defend the Said premises unto the Said Sourdain  
Batson against all persons lawfully claiming or to claim the Same or any  
part thereof Given under my hand and Seal this 31<sup>st</sup> day of August 1832
