 to R. 0 thence S 84 W 37 pine on Paschal Highs line thence S 20 E to the
 Beginning Together with all and Singular the rights Hereditaments
 and Appertinances unto the Said premises belonging or in any
 wise Incident or appertaining to Have and to hold all and Singu-
 -lar the Said premises unto the Said Gilman Smith his heirs and
 assigns forever and I do hereby bind myself my heirs Executors
 and administrators to warrant and forever defend all and Singu-
 -lar the Said premises unto the Said Gilman Smith his heirs
 and assigns against myself and my heirs and against Every
 other person Whomsoever lawfully claiming or to claim the same
 or any part thereof In witness whereof I have hereunto set my
