 State aforesaid in consideration of the Sum of two hundred dollars to me in hand
 by William Barton of the State and district aforesaid do grant bargain
 sell and release unto the said William Barton a certain piece parcel or
 tract of land Situate lying and being in the State and district aforesaid
 on the Sink hole fork of Sugar River it being part of a tract of land
 surveyed for John Gowen the 31st day of August 1786 by Andrew Thomp-
 son and Granted to Cashman Edson 3rd March 1787 beginning on a
 Buck on Bowers branch Ipe Centus corner thence Westerly to the cor-
 ner of said Centus fence to a small pine by a large white oak that stands
 inside of said fence thence on the same course with the fence to the Nor-
 west corner of said fence to a pine at the corner thence down the West
 side of said fence with the fence to a chestnut on the said Centus line of
 Land he bought of John Erickson thence Westerly on the said Centus
 line to a white oak near the head of a very Branch a conditional branch
 made by Abner Centus and others thence on the same to a pine marked
 L thence on to a white oak L thence on to a spanish oak marked L thence
 due West to a red oak thence to a spanish oak thence to a chestnut thence
 to a white oak thence to a chestnut all marked L thence to a chestnut
 on the same direction intersecting with the line of the post oak corner
 of said survey thence north to the Stake corner of said survey near
 the Glassy Rock thence East to Bowers branch thence down the main
 axis of said branch to the beginning containing one hundred and
 fifty acres more or less Together with all and singular the rights
 members Hereditaments and appertinances to the said premises
 belonging or in any wise incident To Have and to hold the above
 mentioned premises unto the said William Barton his heirs and assigns
 from me and my heirs and from no other person or persons whom
 soever and I do hereby bind myself my heirs Executors and ad-
 ministrators to quit claim the above described premises unto the
 said William Barton unto his heirs and assigns and no further
 and the Intent and meaning I am only to warrant and forever
 defend the above from me and my heirs and assigns and no fur-
 ther In Witness I have hereunto set my hand and seal this four-
 tenth day of January one thousand Eight hundred and thirty
 three signed sealed and delivered
