 William Blasingame Sheriff of Greenville District and State aforesaid
 Send Greeting Whereas by Virtue of Sundry Writs of Habeas Corpus issued out of
 the Court of Common Pleas held for the district of Greenville tested the 22nd day
 of October in the year of our Lord one thousand Eight hundred and twenty
 nine at the Suit of Edward Croft J. O Lewis and others to me directed
 Commanding me that of the Goods and Chattles lands and Tenements of
 J. H Goodlett to levy the Sum of twenty four hundred dollars damages and
 Costs I have Seized and taken of the lands and tenements of the Said
 John H Goodlett Deceased all that certain piece parcel and tract of Land
 containing two hundred in Length and fifty two and a half breadth si-
 tuate Situate and being in the district of Greenville Village fronting the
 old Goal Street two Hundred feet and fifty two and a half feet on the
 Public Square Including William Choice's Law office bounded by John
 Brittenden on the North Northwest and East for amore Particular Reference
 conveyed from Alston to Henning from him to Cleveland and from him
 to John Robinson and William Choice and from them conveyed to the
 Said John H Goodlett and Whereas the Said premises with their
 appertanances since the Seizure by me made by virtue of the Said writ of
 Habeas Corpus before mentioned have been Exposed to Sale at Public Vendue
 and Purchased by William Choice of the district aforesaid for the Sum
 of Seven hundred and Seventy dollars being the highest Sum that was
 bidden therefor Now Know ye that I William Blasingame Sheriff aforesaid
 by virtue of the Said writ of Habeas Corpus aforesaid to me directed and
 delivered as aforesaid and by virtue of the Statute in such case made
 and provided and for and in consideration of the Said Sum of Seven
 hundred and Seventy dollars to me in hand paid or Secured to be paid
 by the Said William Choice the receipt and payment whereof I do hereby
 Acknowledge have Granted Bargained and Sold and by these presents
 do Grant Bargain and Sell unto the Said William Choice his heirs and
 assigns forever the Said tract piece and Parcel of land with its appertanances
 and all the Estate right title and Interest which the Said John H Goodlett
 of right had of in or to the Same to have and to hold the Said piece parcel and
 tract of Land with its appertanances unto the Said William Choice his heirs
 and assigns forever as fully and absolutely as I the Said W Blasingame
 might could or ought to Grant Bargain and Sell the Same, by virtue of
 the Statute aforesaid and the Said writ of Habeas Corpus or otherwise in Witness
 Whereof I the Said William Blasingame have hereunto set my hand
 and Seal this First day of May in the year of our Lord one thousand
 Eight hundred and thirty three
