I James McDaniel Sheriff of Greenville district and State aforesaid Send Greeting Whereas by Virtue of Writ of Fieri Facias Issued out of the Court of Common Pleas held for the district of Greenville tested the first day of September in the Year of our Lord one thousand Eight hundred and twenty three at the Suit of Fanny Shelton to me directed Commanding me that of the Goods and Chattels lands and tenements of Hananiah Ray to Levy the Sum of Sixty one dollars and forty three cents damages and costs I have Seized and taken of the lands and tenements of the Said Hananiah Ray all that certain piece parcel and tract of Land containing Six hundred and ninety two acres Situate and being in the district of Greenville Lying on both Sides of lick creek and two Branches the Waters of Enoree River Beginning on a pine 3x Thence South 35 W. 100 to a black Sack 3x S. 85 Thence E. 38. 50 to Red Sack 3x Thence N. 20 E. 74. 30 to Chesnut 3x Thence W. 91. 00 to the Beginning pine corner which land was granted to the Said Hananiah Ray by his Excellency Andrew Pickens Governor and Commander in and over the State of South Carolina Grant bearing date the first day of December 1819 a reference being had to the plat and original Grant will more fully Show Recorded in Grant Book K. N. 8 page 353. and Whereas the Said premises with their appurtenances since the Seizure by me made by Virtue of the Said Writ of Fieri Facias before mentioned have been Exposed to Sale at public Vendue and purchased by Edmond Waddill of the district of Greenville for the Sum of Sixty one dollars and forty three cents being the highest Sum that was Bidden therefor Now Know ye that I James McDaniel Sheriff aforesaid by Virtue of the Said Writ of Fieri Facias aforesaid to me directed and Delivered as aforesaid and by Virtue of the Statute in Such case made and provided and for and Inconsideration of the Said Sum of Sixty one dollars and forty three cents to me in hand paid or Secured to be paid by the Said Edmond Waddill the Receipt and payment Whereof I do hereby acknowledge have granted Bargained and
