Know all men by these presents that I William E Blasingame of Greenville district
and State aforesaid for and Inconsideration of five hundred dollars to me in hand
paid by Richard Gantt of the Same district and State have granted bargained
and sold and by these presents do grant bargain and sell and release unto the Said
Richard Gantt his heirs and assigns all that plantation or tract of land lying
and being in the district aforesaid containing two hundred acres being the
Plantation whereon the Said William E Blasingame lately Resided lying on
a branch of Brushy Creek and a branch of Saluda River begining at a
oak thence Running S 20 E to a post oak thence S 70 W to a post oak thence N 60 W
to a stake thence N 20 E to a post oak and from thence to the begining corner
which Said tract of land was originally granted to Elias Leggett on the fourth
day of July anno. Domini one thousand Seven hundred and Eighty five
and which will more distinctly appear by reference to the original Grant and Plat
thereunto attacht together with all and singular the rights members and
appurtenances thereunto belonging or in any wise Incident or appertaining
to have and to hold the Said tract of land together with all and singular
the rights members and appurtenances thereunto belonging as also all Gold
and ^{other} mines to the Said Richard Gantt his heirs and assigns forever and I
the Said William E Blasingame for myself my heirs Executors and admi-
-nistrators do covenant to and with the Said Richard Gantt his heirs Exec-
-utors administrators and assigns that I am lawfully seized in fee of the
Said tract of land and have the right of passing a fee Simple Estate in Said
Land to Said Richard Gantt and I do bind myself my heirs Executors and administra-
-tors to warrant and forever defend the Said tract of Land and every part and
Parcel thereof together with all and singular the appurtenances thereunto Incident
unto the Said Richard Gantt his heirs and assigns forever against myself and my
heirs and against all and every other person or persons whatsoever and that the
Land is free from all Liens and Incumbrances of dower or otherwise Witness my
hand and Seal this 19th day of September 1833
