State of South Carolina I know all men by these presents that I Richard Pellum of Greenville District and State aforesaid for and in consideration of the Sum of five hundred dollars to me paid or Secured to be paid by William Moon of the State and district aforesaid have Granted Bargained Sold and released and by these presents do Grant Bargain Sell and release to the Said William Moon all that Plantation or tract or parcel of Land Situate lying and being in the district aforesaid on the South Side of South Sygee River Beginning on a Chesnut Post Robert Nelsons corner Running on Said Nelsons line to the River thence down the Meanders of the River to a black W Kendricks line to a black Gum thence on Said Kendricks line a west direction to a black Gum corner thence on Said Kendricks line a south direction to a post oak corner thence along Said Kendricks line near an East course to James Harpers line thence along Said Harpers line to a post oak corner on the Ridge Road leading from Colonel Thomases old place to John Nicholls old place thence up the Said Ridge Road to the place where John Sparkes upper line strikes or comes to the Said Ridge Road thence a north East course or near so to Robert Nelsons line thence along Said Nelsons line to the Beginning containing by Estimation three hundred acres be the Same more or Less Together With all and Singular the rights members Hereafterments and Appurtenances to the Said premises belonging or in any wise appertaining to have and to hold all and Singular the premises before mentioned unto the Said William Moon his heirs and assigns forever and I do hereby bind myself my heirs Executors and administrators to Warrant and forever defend all and Singular the Said premises unto the Said William Moon his heirs and assigns against myself and my heirs and against Every person whomsoever lawfully claiming or to claim the Same or any part thereof in Witness Whereof I have hereunto Set my hand and Seal this 18th day of February 1832 In presence of
