their Executors Administrators and assigns forever and I the Said Sarah  
Spillaw for myself my heirs Executors and administrators the Said above  
mentioned articles unto the Said Gandy W. Long and his Wife Sarah  
their Executors Administrators and assigns against the claim of me  
The Said Sarah Spillaw my Executors and administrators and of  
any other person Whomsoever Shall and Will Warrant and forever  
Defend In Testimony I have Set my hand and Seal this Twelfth day  
of November in the Year of our Lord one thousand Eight hundred  
and thirty three
