Jones for the 2nd Company at Capt Jully Bollinger for the 3rd
Company at Joseph McCallough and for the fourth Company
at Captain Dunbars present Muster Ground Near to James Woods side

Pursuant to an order from Brigadier General Waddy Thompson appointing
us the undersigned Commissioners for the purpose of laying off and dividing
McNeelys Battalion of Col Brockmans Regiment into four great Companies
agreeable to the late act of the Legislature We met and after Mature Deli-
beration have made the following arrangements (to wit) 1st Company Beginning
Where the Regimental line crosses Richland Creek thence down Said Creek
to the mouth thence down Needy River to Ellises old mill thence the old road lea-
ding to Smiths old place now Clevelands thence a straight line to Cothrans
old ford on Saludia thence up Said River to the Regimental line thence to
the Beginning place of Rendezvous, Cross Roads or Blakeys old place 2nd
Company Beginning at Ellises old mill on Needy River thence down Said
River to the Battalion line thence along the Battalion line to Saludia
River thence up Said River to Cothrans ford thence by Smiths old place
to the Beginning place of Rendezvous Jones old meeting House near George
Crafts 3rd Company Beginning Where the Regimental line crosses Richland
Creek thence down Said Creek to the mouth thence down Needy River to the
Battalion line thence the Battalion line to where it crosses the Road leading
from Gunners by Col Austins to Sisters Factory on Enore River thence
Said road to the Beginning Regimental line thence Said line to the
Beginning Place of Rendezvous McDanils Cross Roads, 4th Company Beg-
inning at Sisters Factory on Enore River thence down Said River to the Laurens
line thence along Said line to where it intersects the Battalion line thence
