Sells alien and confirms and Enfeoff a certain tract or parcel of Land  
containing four hundred and twenty Six acres more or less Situate  
in Greenville District South Carolina on Waters Bushy and Mountain  
Creek Waters of Enore which land was granted unto Forrest Hudson  
in year Seventeen hundred and ninety three bounded by lines  
Running N. 70. W on Samuel J. Absters to Stake thence S. 39. E. 111 to  
Stake thence N. 63. E. 77. 50 to Sowerwood which was the beginning  
unto the Said Lynn Walker Together With all and singular the  
premises the Waters and Water courses and Every thing appertaining
