W. 3. 75 to a chert P. 69. E. 67. 50 to a pine on a conditional line made by Stephen Philips and William Baker thence down the ridge on the said conditional line to the Beginning also one other tract or parcel of land containing four hundred and fifty six acres be the same more or less it being for the same consideration of the above sum Beginning on a Stake thence N. 10. E. 30 to a stake N. 70. W. 82 to a stake S. 70. E. 48 to a Stake thence S. 5. E. 13 to a stake containing five hundred and fifty six acres be the same more or less Together with all and singular the rights and members Hereditaments and appurtenances to the said premises belonging or in any wise belonging or appertaining thereunto to have and to hold all and singular the premises before mentioned unto the said William Fuller himself his heirs & assigns forever and I the said Jonathan Fuller do hereby bind myself my heirs Executors and assigns to warrant and forever defend all and singular the said premises unto the said William Fuller his heirs and assigns against myself my heirs and assigns and from all Every person or persons whatsoever laying any lawfull claim to the said premises or any part thereof in Witness Whereof I have hereunto set my hand and Seal this 23rd day of December in the year of our Lord one thousand Eight hundred and thirty two
