of the Sum of four hundred dollars to me in hand paid by Darius Green  
of the State and district aforesaid do Grant bargain sell and release  
two tracts of Land one containing ninety six and a fourth acres the  
other containing twenty four & a fourth to Darius Green it being a part of  
a tract of Land originally granted to by Juan Farrow on the fifteenth  
of October one thousand seven hundred and eighty four by his Excellency  
Governor Benjamin Guard and surveyed by James Seaborn and having  
been conveyed to Richard Kemp Deceased and by us his heirs and  
did and hath such Shape marks &c as is here stated to wit the  
tract of ninety six and a fourth acres beginning at brushy creek run-  
ning thence North 30. E. 41 chs 50 links to R. Oaks corner thence North  
60 West 23 chs 75 links to Stake thence South 30. W. 39. chs 75 links to Creek  
thence South 56 East 24 chain down said creek to the beginning the other  
tract of twenty four & 1/4 acres beginning at South branch of said creek and  
runs North 30 East 31 chains to a stake thence North 60. W 21 chs 25 links  
to pine corner thence South 30 West 16 chains 50 links to said South branch  
of said creek thence down said branch to the beginning I do therefore  
Grant bargain sell and release and forever quit claim to the above  
parcels or tracts of Land unto the said Darius Green his heirs assigns  
Executors or administrators free from the claim of myself my heirs  
Executors or administrators and assigns and all other persons lawfully  
claiming the same or any part thereof wherein I bind myself my  
heirs Administrators or assigns forever given under my hand & seal  
this twenty second day of October A.D. one thousand eight hundred  
& thirty three
