

286 The State of South Carolina Know all men by these presents that I Stephen Holtzelaw of Greenville district in the State aforesaid Labourer in consideration of the sum of Four Hundred dollars to me paid by Elijah Holtzelaw of Greenville district in the State aforesaid have Granted Bargain Sold and released and by these presents do Grant Bargain Sell and release unto the Said Elijah Holtzelaw all that plantation or tract of Land containing two hundred and forty acres be the same more or less Situate Lying and being in Greenville District in the State aforesaid on princes Creek Waters of Enoree River the same being part of two tracts of Land originally granted to Joseph McGoughlon being date the twenty first day of January (D. 1785 and the first of January Date 1787 reference thereunto being had will more fully appear Beginning on an oak corner \times on the North of a branch of the aforesaid Creek thence S. 62. E to a willow corner \times in the fork of said Branch thence up the South prong running the Meanders to a ash corner \times on the aforesaid prong thence N. 6. E. Chain 36 links red oak corner \times old marked thence South 60. E. 60 chains to an oak marked \times thence S. 20. W. 20 chain to a black Jack marked \times thence S. 80. W. 25 Chains 50 links to an oak \times thence N. 40. W. 27 chains 50 links to a post oak \times thence S. 50. W. 35 chains to the Creek thence up the Meanders of the said Creek to the upper line of the first Survey thence N. 30. E. ch to a black oak \times thence a straight line to the Beginning red oak corner near the Branch together with all and singular the rights members Hereditaments and appurtenances to the said premises belonging or in any wise incident or appertaining to have and to hold all and singular the premises before mentioned unto the said Elijah Holtzelaw his heirs and assigns forever and I hereby bind myself my heirs Executors and Administrators to Warrant and forever defend all and singular the said premises unto the said Elijah Holtzelaw his heirs and assigns against myself my heirs and against Every person Whomsoever lawfully claiming or to claim the same or any part thereof Witness my hand and Seal the 29th September 1834 and 59th year of American independence
