to the pine corner on Micajah Jenkins line thence on the Same to the post oak
3x on Winns line thence on the Same N. E. 24° to the original corner a white
oak by a branch thence down the branch to Griddle Creek and down the
Same by common High Water Mark as it now Runs to Reedy River thence down
the middle of the River as it now usually Runs to the beginning containing
five hundred acres be the Same more or less being part of Three several tracts
Viz Thomas Jenkins Genl Richard Wynn and Micajah Jenkins to Have

line between Nubys old tract and Z Bensons thence to a spanish oak thence
to a pine thence to Black Locust thence to a mountain oak on the mountain
Path & Sheltons line thence along said path to a black Jack corner on
Sheltons line and Nubys old line thence a conditional line to the beginning
being apart of David Burns old tract together with all and singular the rights
members Hereditaments and appertinances to the said premises belonging
or in any wise incident or appertaining to Have and to hold all and singular
the premises above mentioned unto the Said Marshal Shelton his heirs and
assigns forever and I do for myself my heirs Executors and administrators
Warrant and forever defend all and singular the premises above mentioned
unto the Said Marshal Shelton his heirs or assigns against myself my
