 furniture also forty barrels of Corn and four stacks of fodder also one
 cart & steers to have and to hold the said described land horses Cattle
 & Hogs House hold & Kitchen furniture Cart & steers Corn & fodder all as a
 bove mentioned unto my said Children and Step son Abraham Elizabeth
 John George Susan Caroline & Harriet their Executors administrators and assigns
 forever and I the said George Willimon myself my heirs Executors and
 administrators do warrant and forever defend the said property above
 mentioned (viz) land Horse Cattle Hogs House hold and Kitchen furniture
 one yoke of steers and Cart Corn & Fodder all as above described unto my
 Children as above named their heirs Executors administrators & assigns
