South Carolina Know all men by these presents that I John Jones (Senior) of Greenville for an & Consideration of seven Hundred dollars to me paid by Edmund Jones have Granted Bargained Sold and Released and by these presents do Grant Bargain Sell and Release unto the said Edmond Jones all that plantation or piece of Land on which I lately lived situate in Greenville District on Durbin's Creek Waters of Enoree River containing 289 acres of Land more or less 142 acres of which was conveyed to me by Richard Jones the 15<sup>th</sup> of March 1831 Beginning at an ash on Durbin's Creek at the mouth of a spring branch and runs up said branch N 83 W 29 chs to a poplar 37 n on thence N 57 W 30 chs to a pine stump in field then S 33 W 31 50 to another oak 37 n on on said Creek and down said Creek to the Beginning 147 acres was conveyed to me the 3<sup>d</sup> of September 1800 by William Jones being part of a tract Granted to Thomas Fair the 8<sup>th</sup> July 1774 bounded by the first lot Beginning at a post oak 37 and runs S 45 W 29 chs to a hickory or red oak thence S 66 E 8 chains to a pine 37 n on then S 58 E 38 to a hickory 37 n on then N 70 E 19 chains to a pine 37 then N 25 Chains to a stake on Wagon Road and up said Road to the Beginning post oak Together with all and singular the rights members Hereditaments and appertinances to the said premises belonging or in any wise Incident or appertaining to have and to hold all and singular the premises unto the said Edmond Jones his heirs and assigns forever and I do hereby bind myself my heirs Executors and Administrators to Warrant and defend all and singular the aforesaid premises unto the said Edmond Jones his heirs and assigns against myself and my heirs and against every other person or persons whomsoever lawfully claiming or to claim the same or any part thereof Witness my hand and seal this 25<sup>th</sup> day of March 1835
