 Vincent Thompson of Greenville District and State aforesaid in consid-  
 eration of Eleven hundred and forty dollars to me paid by Martin Stone of the  
 State and district aforesaid have granted bargained sold and released  
 and by these presents do grant bargain sell and release unto the said  
 Martin Stone all that plantation or tract of Land containing one hundred  
 and ninety acres more or less situate in the State and district aforesaid  
 lying on Saluda River beginning on a Post Oak 3x on the South of the  
 hickory running thence N 76° 50' East to hickory 3x bounded by Joseph W.  
 Callough thence S 63° 20' to a hickory 3x thence N 82° 41' 40" to a Station  
 3x thence S 34° 46' 35" to a Black Oak 3x bounded by the said Martin  
 Stone's Land thence S 49° 40' 45" to a Beach 3x on the River bounded by  
 I French's Land thence up the meanders of said river to the beginning  
 To gether with all and singular the rights members here determined  
 and appertinances to the same belonging or in anywise incident  
 or appertaining to have and to hold all and singular the premises  
 above mentioned unto the said Martin Stone his heirs and assign-  
 agents forever and I do hereby bind myself my heirs Executors and  
 administrators to warrant and forever defend all and singular  
 the said premises unto the said Martin Stone his heirs and assign-  
 agents against myself and my heirs and against every other person  
 whomsoever lawfully claiming or to claim the same or  
 any part thereof with my hands and seal this the third  
 day of August in the year of our Lords one thousand  
 eight hundred and thirty six Signed sealed and  
 delivered in presence of
