and thirty five between Millie Hammell Elizabeth Hammell Jyffee  
Hammell Daniel Pike and Sally his wife Caleb Green and Nancy his wife Davies  
green and Elender his wife Jonathan Hammell & Martha Hammell on the one  
and part and Joel Hammell on the other part all of this District & State aforesaid  
whereas John F Hammell late of the District aforesaid died having died in  
said state seized and possessed of certain lands situate in said District and the above  
named persons being all the heirs and representatives of the said John F Hammell  
the same all of full age did enter into an agreement to sell the aforesaid lands out  
of convenient lots to the highest bidder on a credit of twelve of months and  
whereas in pursuance of said agreement after duly advertising said lands for sale  
the lot No 2 therein after described was on the 8<sup>th</sup> day of January in the year above  
mentioning was exposed to sale by public auction when the said Joel Hammell was the  
last and highest bidder to whom the said lot of land was struck off for the sum of  
three hundred and two dollars Now this Indenture witnesseth that in  
the sum of three hundred and five dollars to be secured to be paid  
to us or have granted Bargained sold and released and by these presents do grant, bargain  
and release unto the said Joel Hammell and his Heirs and assigns for ever, the  
acres of land above mentioned situate in said District on the waters of Little swamps  
Parker's creek waters of Tyger river, and Enoree river, containing one hundred and  
forty seven acres more or less of land being the part of a tract of land of the said  
deceased and part of an original grant of land to George Wright and bought by  
the said dec'd of the heirs of John Green deceased and hath such bounds marks  
and corners follows (N.W.) beginning on a post oak 3x thence N 30 E 45 chains to a  
Spanish Oak 3x thence S 63 E 31 ch. 50 links to a Stake S 30 W 36 ch. 50 links to  
a Stake 3x thence N 6 W 11 ch 18 links to a Spanish Oak, thence S 45 W 7 ch 50 links
