 and conveyed, and by these presents do give, grant bargain, sell, release &
 convey unto him the said James Gidley all that tract or parcel of land situated
 lying, and being, in the State and District, on both sides of Mill Creek
 west of South Pacolet River and bounded as follows, Beginning at a red
 Oak 37, thence running N 18 W 42 Chains 20 links to a Chestnut 37
 thence N 10 E 12 1/2 Chains to a Chestnut 37, thence N 55 E 17 Chains to links
 to a Chestnut 37, thence S 25 E 9 Chains to a Chestnut 37, thence S 73 E 8
 Chains 20 links to a poplar 37, thence a south course to a line known as
 John and William McClendon's line, thence with said line to the beginning
 containing one hundred acres, be the same more or less. To have and
 to hold the above granted premises unto the said James Gidley
 his Heirs and assigns forever. Together with all and singular
 the rights members hereditaments and appurtenances thereto
 belonging or in anywise incident or appertaining. And the said
 John Waldrup do hereby bind myself, my Heirs Executors Ad-
 ministrators and assigns forever to warrant and defend the above
 granted premises unto him the said James Gidley, his Heirs and
 assigns against myself my Heirs and assigns and against
 any and every other person person or persons whomsoever lawfully
 claiming or to claim the same or any part thereof. In witness
