 bargain, sell, release and confirm unto the said Zion Mafsey, his heirs  
 and assigns a certain tract of land situate in Greenville District containing  
 one hundred and thirty five acres more or less (beginning) at a post  
 oak corner and running E 16 to a stake thence N 30 E 14.50 to a  
 post oak thence S 63.07.50. to a pine thence N 21 E 37.00 to a black  
 oak, thence N 51 W 54 to a stake, thence S 63. W 17 to a stake +  
 thence S 53.00 chains to the post oak at the beginning, as the plat  
 fully represents. Together with all and singular the Hereditaments  
 rights members and Appurtenances whatsoever to the said tract of land be-  
 (ing) or in anywise appertaining, and the reversions, and remainders, rents  
 issues and profits thereof and also all the estates, rights, titles Interest down  
 & possession property, benefit claim and demand whatsoever of the heirs and  
 representatives of the said James Garrett, and of all other persons rightfully  
 claiming or to claim the same, or any part thereof, by from or under them  
 or either of them to have and to hold the said tract of land with all heredita-
