 Rebecca Barnett deceased, (late wife of John Barnett a certain lot or parcel
 of land, being) part of the tract of land I now live on, containing by estimation
 forty five acres (be the same more or less) lying on the waters of Middle
 Tiger river in Greenville District, beginning on a black oak on the bank
 of a small branch, thence West 9 Ch 70 L to a persimon on Campbell's line
 thence with said line S 21 Ch 75 L to a black oak. thence West 9 Ch 50 L
 to a Spanish oak, thence S 9 Ch 50 L to a hickory on the road, thence with
 the road S 84 E 11 Ch. 25 L to a red oak, thence nearly North down a hollow
 to the head of a small branch, thence down the branch as it meanders to the
 (beginning) corner by estimation forty five acres for the consideration of the
 sum of two hundred Dollars to me in hand paid by Ebenezer Tillary Rebecca
 Barnett, the receipt whereof I do hereby acknowledge. Together with all and
 singular the above mentioned premises unto the sd Ebenezer Tillary Rebecca
 Barnett, their heirs and assigns for ever, and I do hereby bind myself my
 heirs and assigns to warrant and for ever defend the said premises unto the
 sd Ebenezer Tillary Rebecca Barnett, their heirs and assigns against my
 self, my heirs and assigns and against all and every other person or persons
 claiming the same for any part thereof In witness whereof I have set
 my hand and seal this August 3rd in the year of Our Lord one thousand eight
 hundred and thirty eight Fifty seven and third of American Independence
