South Carolina. Know all men by these presents that I Henry James of  
Greenville District in the state aforesaid for and in consideration of two hundred  
dollars to me paid have granted bargained sold and released and by these presents do  
grant bargain sell and release unto Ethel Holtzclaw all that parcel of Land being  
two pieces cut from the tract on which I now live containing sixty three Acres and a  
half, more or less situated in said District on the branches of Enoree River -  
Beginning at a Post corner on Ethel Holtzclaw line and runs S 81 E 4 Chains  
to a pine 3X (new) thence S 15 E 26 Chains 50 links, to a stone on the wagon road 3X  
thence along said S 31 W 12 Chains, and fifty four links 3X to a chestnut near then  
to the beginning N 28 E 14 Chains, 1 link 3X The second piece begins on John Greenes  
and Jesse Shucklys corner and runs N 51 W 31 Ch, 50 links to a stone corner in a road  
3X thence along said road S 25 E 14 Chains to a chestnut 3X near on the East side of said  
road thence S 42 E 11 Chains 50 links to a stake 3X thence N 45 E 24 Chains to the beginning

Together with all and singular rights members hereditaments and appur-  
tenances to the said premises belonging or in anywise incident, or appertaining  
to have and to hold all and singular the said premises unto the said Ethel  
Holtzclaw his heirs and assigns forever and I do hereby bind myself my heirs  
Executors and Administrators to warrant and forever defend all and singular  
the said premises unto the said Ethel Holtzclaw his heirs and assigns against  
myself my heirs and against every other person or persons whomsoever lawfully  
claiming or to claim the same or any part thereof witness my hand and seal  
this twenty third day of March in the year of our Lord one thousand eight hundred and  
thirty nine and in the sixty fourth year of American Independence Signed Sealed  
and Delivered in presence of us.
