 hereby acknowledged have granted bargained sold and released and by these presents
 do grant bargain sell and release unto the said Samuel Styles a certain tract
 or parcel of land containing five hundred and fifty acres be the same more or
 less situate in District and State aforesaid on Moore River line beginning on a
 P.C. x thence S 70 E 15 C. to a chestnut thence along a ~~convenient~~ conditional
 line to a W.C. x thence down the meanders of the said branch to a large poplar
 thence N 56 E. 12.5 to a white Oak 3x thence S 15 E 38.5 C. to a Spanish Oak 3x
 dead & down thence South East to 13 Oak 3x thence S.E. to the mouth of a branch
 at Moore River to a stake 3x thence S. 10. to another stake 3x thence S.W. Course
 to a perpendicular 3x thence N.E. to a stake 3x on an old Road thence N 22 E.
 8 to a stake 3x thence S 62 W. 17 to a Chestnut 3x from thence to a maple 3x from
 thence to an ash 3x thence N 64 W. 12.50 links to a lightwood stake on a path thence
 along said path to a stake on Blackwell's old line thence with the said line to
