To have and to hold the said Negro Malinda and her increase to them the said children of my said daughter Emily for ever clear from the claim of all persons whomsoever. In witness whereof I have hereunto set my hand and affixed my seal this 15th day of September in the Year of our Lord one thousand eight hundred and thirty four.

C. 3⁺ N 50 E. 16. 50 to a Black Jack 3⁺ thence by a conditional line in the same direction to the original line thence on the original line to the beginning it being a part of a tract of Land originally granted to John Gilliland and conveyed to George J. Pillar containing one hundred acres more or less together with all and singular the rights members hereditaments appurtenances to the said belonging or in any wise incident or appertaining thereto to have and to hold all and singular the premises before mentioned unto the said John Riddle and I do hereby bind myself my heirs Executors Administrators & assigns to warrant and forever defend all and singular the premises before mentioned unto the said John Riddle his heirs Executors Administrators & assigns against myself my heirs and against every other person or persons whomsoever lawfully claiming or to claim the same or any part thereof in witness whereof I have hereunto set my hand and seal this the 9th day of January in the Year of our Lord one thousand eight hundred & thirty five and in the 5th Year of the Independence of the United States of America signed sealed & delivered in the presence of us
