send greeting. Whereas, by virtue of a writ of fieri facias, issued
out of the Court of Common Pleas held for the district aforesaid tested
the thirteenth day of October in the Year of our Lord one thousand
Eight hundred and thirty Eight at the suit of St Roy M Wiley Parish
Plaintiff vs Holstein Roberts & Dennis Westmoreland Defendants,
to me directed, commanding me, that of the goods and Chattels Lands
and tenements of the said defendants, to levy the sum of one thousand
and fifty Eight & five Cents and thereon Interest damages & costs, I have
seized and taken, of the lands and tenements of the said Dennis West-
moreland all that certain piece, parcel and tract of land, containing
two hundred and seven acres more or less situate and being in the
District of Greenville aforesaid adjoining Lands of Elizabeth Stan-
ford Mrs Roddie John Lynch & others on waters of Mush Creek
waters of Tyger River - And whereas the said premises with their
appurtenances, since the seizure by me made, by virtue of said writ
of fieri facias before mentioned have been exposed to sale at pub-
lic Vendue, and purchased by Chary Stroud of the said Dis-
trict for the sum of four hundred and forty Dollars that being
the highest sum that was bidden therefor - Now Know Ye that
I David Menning Sheriff aforesaid by virtue of the said
writ of fieri facias aforesaid, to me directed as aforesaid and by
virtue of the statute in such Case made and provided, and for
and in Consideration of the said sum of four hundred and forty
dollars to me in hand paid or secured to be paid by the said Chary
Stroud the receipt and payment whereof I do hereby acknowl-
edge, have granted bargained & sold and by these presents do
grant bargain and sell unto the said Chary Stroud his
heirs and assigns for ever, the said tract, piece and parcel of land
with its appurtenances, and all the estate, right title and interest
which the said Dennis Westmoreland of right had of in and to the
same - To have and to hold the said piece parcel and tract of Land
with its appurtenances unto the said Chary Stroud his heirs
