by these presents do grant, bargain sell and release unto the said William Rabe &
his wife Permilia Rabe. All that tract or Plantation of Land lying on both sides of Gilders
Creek waters of Enom River containing by survey seven hundred and fifty four acres be the same
more or less adjoining Lands of Richard Berry, 19 Town. Co of Butler. & Bauldin. P B Hill
Daniel Fortin and P B Hill being the same whereon I now live the Lands meant to be con-
veyed is the same that is represented in a Plat hereunto annexed made by Josiah Hel-
gore Esq. which is intended to be a part of this deed. Together with all and singular
the Rights, Members, Accreditments and Appurtenances to the said Premises belonging or in any wise
incident or appertaining: To have and to hold all and singular the Premises before mentioned
unto the said William Rabe and Permilia Rabe their Heirs and Assigns forever. And I do
hereby bind myself. My Heirs, Executors and Administrators to warrant and forever defend all and
singular the said Premises unto the said William Rabe and Permilia Rabe their Heirs and
Assigns against me and my Heirs, and against every person whomsoever lawfully claiming
or to claim the same or any part thereof.
