Together with all the rights members hereditaments and appurtenances thereunto belonging or in anywise Belonging To Have and to hold all and singular the said parcel or tract of Land to the said Caleb Green his heirs Executors administrators or assigns and do hereby bind myself my heirs Executors or administrators and assigns to Warrant and forever defend the said premises to the S<sup>d</sup> Caleb Green his heirs and assigns against myself my heirs as well as all other persons lawfully claiming the same or any part thereof in witness whereof I have hereunto set my hand and affixed my seal this second day of June 1836
