 mentioned then and in that case this deed of bargain and sale and all and every
 clause article and thing therein contained shall cease determine and be utterly
 void and of none effect any thing herein contained to the contrary though in any
 wise notwithstanding. And it is hereby declared by and between the said parties
 and I the said David Henning for myself my heirs ^{administrators} executors, and assigns do
 covenant promise and agree to pay to and with the said Vardy M^r Bee -
 B. Dunham, Peter Couble, R. Lovland, S. R. Whittow & William Blasingame
 their Executors administrators and assigns by these presents that if they or any
 of them have any money or moneys to pay for me as my securities on the bond
 above mentioned or shall incur in any way any liability and which I shall not be
 able to meet and release them and in ^{case} it shall and may be lawful to and for the
 said Vardy M^r Bee, B. Dunham, Peter Couble, R. Lovland, S. R. Whittow and William
 Blasingame their Executors administrators and assigns, attorneys or agents from
 time to time and ^{at} all times hereafter peacefully and quietly to enter into any or
 all messuages lands or tenements of the said David Henning and to take into custody
 and possession of the same to hold & detain to their own use and behoof as their
 own proper goods and chattels from hence forth and forever or the same to sell
 & dispose of at will & pleasure, returning the surplus if any should happen to
 be after paying the said sum or sums of money which they may have to pay
 on the bond or as securities to the said ^{said} Henning for his acts and conduct
 as sheriff of Greenville District to the ^{said} Henning his heirs & executors -
