district and State aforesaid. Have granted bargained sold and Released and by these presents
do grant bargain sell and release unto the said Hardy J. Gilreath all that tract or parcel
of land containing One hundred acres be the same more or less situate lying and being
in the district and State aforesaid on the waters of Enoree River and South side of said
River beginning at a Red Oak at the North side of a Road leading from Sigals Mills to
McChaug's Ford on Saluda River. Running thence Northw'dly a boundary line
to a Hickory on Samuel Styles line thence Westwardly an open line ending on
said Styles line to a Black Oak thence Southwardly on Styles line to the said H. J.
Gilreath's line thence along said line to the above mentioned road thence Eastwardly
along the said Road to the Beginning Red Oak corner also twenty five acres
more situate as aforesaid beginning at the line of the above conveyed tract on a
Red Oak thence Northwardly to a Red Oak at the South Bank of Enoree River
thence down the meanders of said River to Blackman Sigals line thence Southwardly
on Sigals line to the intersection of the above conveyed One hundred Acres.
