





State of S Carolina & I Reuben Martin one of the Justices of the Quorum do

 all her Interest and Estate and also, all her Right and claim of Dower
 of in or to all and singular the premises within mentioned and Released
 given under my hand this 16th of May 1840

 Greenville District of Fenby Smith for the sum of fifty dollars to me in hand paid
 by Levi W. McDaniel have bargained sold and released and by these presents do bar-
 gain sell and release unto the sd. McDaniel all my part of a tract of land convey-
 ed to Fenby and Harriet Smith by their Father by deed situated on the waters of
 Middle Saluda River containly a late resurvey and ptat Seventy five Acres
 be the same more or less and both such shape forms butting and bounding
 as the ptat represents to have and to hold the premises as abov described unto
 the s^r Levi McDaniel his heirs and assigns forever. Together with all and
 singular the rights members and appurtenances in any wise incident or
 appertaining therunto and I bind myself my heirs to warrant and for
 defend the same to the s^r McDaniel and his assigns from me myself and
 all and every other persons lawfully claiming the same in testimony I have
 set my hand fixed my seal this 24th June A.D. 1839 signed sealed and deliv-
 ered in presence of Sarah ^{her} Gist  & W. M. Jewell

 a Branch of the Middle fork of Saluda River joining lands of Joseph
 Smith Jeremiah Cleveland and others beginning at A Red Oak corner
