Greenville District } Lewis of the district of Greenville in the State aforesaid for and in consideration of the sum of Thirteen hundred and Twenty three dollars, 75<sup>cts</sup> to me in hand paid by Margaret B. Machom of 2<sup>d</sup> district in the State aforesaid, have granted, bargained, sold and released and by these presents do grant bargain sell and release unto the said Margaret B. Machom, All That tract or parcel of lands parts originally granted to Henry Machom and Jesse Moody and now the residence of the said Mary W. Lewis, containing by survey One hundred and seventy six acres, be the same more or less, having such bounds more or less as follows viz<sup>d</sup> Beginning at a Stone corner on Jeremiah Cleveland's line, thence along the present lane N 83 E 53.50 chs to a Stone corner - thence S 54 E. 22.25 chs to a Stone + III on Cleveland's line, thence S 21. W 10<sup>ch</sup> to a Stone on the Branch, thence down the meanders of the Branch to a Stone + III at the lower end of a ditch on Cleveland's line, thence along said line N. 59. W. 46. 25. to a Pine Corner, thence N. 58. E. 14 chs to a Stone 3x thence N 27. West. 90 links to the Beginning, which said lands are parts of Grants made to Henry Machom and Jesse Moody as aforesaid, the said Mary W. Lewis reserving one acre around the Grave yard which is reserved as a family burying ground. Together with all and singular the rights, members hereditaments and appurtenances to the said Premises belonging, or in anywise incident or appertaining. To have and to hold, all and singular the premises before mentioned, unto the said Margaret B. Machom her heirs and assigns forever. And I do hereby bind myself my Heirs, Executors and administrators, to warrant and forever defend, all and singular the said premises unto the said Margaret B. Machom her heirs and assigns, against myself and my Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
