 Greenville District that I James Nabors of the State
 and District aforesaid and in consideration of the sum of four
 hundred and fifty Dollars to me in hand paid by John McCurtain
 of the State and District aforesaid have granted, bargained and
 sold and by these presents do grant bargain and sell to the said
 John McCurtain one hundred and thirty Eight acres more
 or less of land lying in said District on a branch of ^{the} Kedy
 Fork of Kedy River being part of a tract of land granted to
 Cadwalader Jones assigned by His Excellency Thomas Pinckney
 on the third day of December 1787 also a part of a tract of
 of land granted to Robert Gilliam and assigned by His Excellency
 Thomas Pinckney on the seventh day of April 1788 the said
 tract of land now laid out to the said John McCurtain is
 follows; Beginning on a pine corner on Jesse Moon's land thence
 N 55 W 9 ch to a Hickory thence N 33 E 15^{ch} 25 links to post oak
 thence N 38 W 55 ch to a stake on John McCurtain's line
 thence N 28 E 7 ch to post oak thence S 62 E 33 ch to post oak
 thence S 6 E 12 ch to poplar on Theodoric Farmer's land
 and from thence to the beginning corner
