 dollars to me in hand paid by Emanuel Linza of the State and  
 District aforesaid, the receipt whereof is hereby acknowledged have  
 granted, bargained, sold and released and by these presents do grant  
 bargain, sell and release, confirm and convey unto the said Emanuel  
 Linza all that plantation tract or parcel of Land containing one hundred  
 acres more or less, situate lying and being in the State and District  
 aforesaid on the head water of Pacolet and North fork of Saluda River  
 Beginning on a white oak thence North Sixty Degrees East Seventeen  
 chains to a Hickory thence South Twenty Degrees West Twenty four chains  
 to a Stake thence North Seventy seven degrees West Thirty four chains  
 to a Stake thence North Seventeen degrees East Twenty one chains  
 to a Stake and thence to the beginning - It being part of a certain  
 tract of land granted to John Wheeler and conveyed by him  
 to Aaron Templeton and from him to his heirs and by them to George  
 Linza - Together with all and singular the rights, members, hereditaments  
 and appurtenances to the said premises belonging or in anywise inci-  
 dent or appertaining - To have and To hold all and singular the  
 premises before mentioned unto the said Emmanuel Linza his heirs and  
 assigns forever - And I do hereby bind myself my heirs, Executors and  
 Administrators to warrant and forever defend all and singular the said premises
