 and against me and my heirs, executors, administrators, and assigns and all persons whom-  
 -soever lawfully claiming or to claim the same, or any part thereof, provided always  
 that the said Robt. Cox, his heirs, executors, administrators, and assigns shall pay, or cause to be paid, unto the  
 said Robt. Cox or his heirs, executors, administrators or assigns, the said debt or sum  
 of money aforesaid, with the interest thereon, if any shall be due, according to the true  
 intent and meaning of the said bond and condition hereunder written, then this deed  
 of Mortgage and Sale shall cease, determine, and be utterly null and void, otherwise  
 it shall remain in full force and virtue, and it is agreed, by and between the said par-  
 -ties, that the said Robt. Cox, his heirs and assigns shall enjoy the said premises until
