Moon for the consideration of the sum of thirteen hundred dollars to me in hand paid the receipt whereof I do hereby acknowledge the payment thereof I have granted, bargained and sold and released unto Lewis Rice all that tract of Land and plantation situated in Greenville District on Pyles Branch waters of Rudy River containing agreeable to a survey made by Samuel Moore three hundred and twenty two acres be the same more or less Beginning at a small Red oak corner just below where the mill stands running thence S. 26. E. 15. Ch. to a Stake corner thence S 39. W. 60. 50 Ch. to a Stump corner thence N. 60. W. 32. 50. Ch. to a young Red oak corner thence N. 19. E. 75. 22. to a Sourwood corner thence S. 50. E. 34. Ch. to a Stake thence S. 50. E. 10. 50. Ch. to a small Red oak thence S. 47. W. 2. 75 Ch. to the beginning Red oak corner having such other shapes, buttings & boundaries as are represented in a plat thereof made by S. Moore on the 7<sup>th</sup> October 1835 Together with all and singular the rights members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining To have and to hold all and singular the premises before mentioned unto the said Lewis Rice his heirs and assigns forever and I do hereby warrant and defend and warrant my heirs and assigns for ever to defend all and singular the said premises unto the said Lewis Rice and myself and heirs and assigns and against every other person or persons lawfully claiming or to claim the same or any part thereof In Witness whereof I have hereunto set my hand and seal this the 21<sup>st</sup> day of February in the Year of our Lord one thousand eight hundred and forty two Signed sealed and delivered in the presence of Saml.
