Henry Parris of South Carolina & Greenville District know all men by these presents that I, Henry Parris of the District of A. B. Cobb State aforesaid for & in consideration of the sum of eleven hundred & ten dollars to me paid by Amaziak B. Cobb of the same State & District, the receipt whereof, I do hereby acknowledge have granted, bargained, sold and released and by these presents do grant, bargain, sell & release unto the said Amaziak B. Cobb, a certain tract, or parcel of land containing by a late survey four hundred & twenty two acres, more or less, situate in said District on Saluda River and on both sides of the road leading to Wilsons Ferry or bridge on said river & being the same tract of land conveyed by William Bowen to Mary Bowen by deed bearing date the 30th day of May 1810, and conveyed by the said Mary, to Charles Garrison and sold as the property of the said Charles Garrison by William M. Goodlett, Sheriff of said District and conveyed by said Goodlett, to me by deed bearing date the 4th day of July 1842, it being part of an original grant to Reuben Stringer & Ambrose Blackburn. The land now to be conveyed has such bounds marks &c. as follows, viz. Beginning at a Stake 3x on Saluda River thence N. 70 E. 37 chs to a Stake 3x, thence N. 68 E. 47 to a Stake near the above mentioned road, thence N. 45 E. 3. 60 chs to a Stake 3x thence N. 70 E. 13. 30 chs to a Post Oak 3x, thence S. 15 E. 22 chs to a Stake 3x thence S. 8 W. 32. 50 chs to a Stake 3x thence N. 62 W. 6 chs to a P.
