 one hundred and twenty five Dollars
 in hand paid, have granted, bargained and sold &
 unto Jacob Garrett & Pleasant Garrett their heirs & assigns
 a certain tract of land lying on the long branch, waters
 of Wilsons Creek containing fifty acres more or less. Be-
 ginning on poplar on Wm. Johnsons line, it being an
 Conditional line between the two parties, running thence
 to the Spring which is now occupied by Nicholas Gar-
 rett thence continuing on nearly the same course to a
