

 release, unto the said Petsy Ann Edwards, a certain tract or parcel of
 land lying on the Marrow Pine Creek, containing One Hundred and
 Twenty-Five Acres, be the same more or less, Beginning on an Oak in the
 Marrow Pine Creek, thence S. 10 1/2 E. 42.84 chains to Rock on the road lead-
 ing from Josiah Hawkins to Brushy Creek Meeting House thence S. 2 1/2 W.
 8.50 chains to Pine 3 x 0. m. on branch thence N. 62 E. 2.42 chs. to Stake
