Know all men by these presents that I, Lewis Nabors, of the State and District aforesaid, for and in consideration of the sum of Three hundred and Eighty-seven Dollars and fifty Cents paid by Jesse Moon of the State and District aforesaid, have granted, bargained and sold, and by these presents do grant, bargain and sell to Jesse Moon, One hundred and thirty-eight acres, more or less of land lying in said District on a branch of the Reedy Fork of Reedy River, being part of a tract of land granted to Cadwalader Jones aforesaid by his Excellency Thomas Pinckney on the third day of December 1787. Also a part of a tract of land granted to Robert Ellam and aforesaid by his Excellency Thomas Pinckney on the seventh day of April 1788, The said One hundred and thirty-eight acres of land more or less is laid out to the said Jesse Moon, as follows, beginning on a pine 3 x in James Crearners land on Jesse Moors Thence N. 55 W. 9 chain to Hickory 3 x thence N. 33 E. 15. 25 to a post oak 3 x Thence N. 38 W. 55 to a stake 3 x on Samuel Bollings Land near Abner H. Quitters Thence N. 28 E. 9. 50 to a post oak 3 x on said line Thence S. 62 E. 53 to a post oak 3 x Thence S. 6 E. 12 to Poplar 3 x on Paschal Rutledge land near Theodericks Farmers and thence to the beginning corner including one hundred and thirty-eight acres more or less together with all and singular the rights, members and appurtenances to the same belonging or in anywise incident to have and to hold to the said Jesse Moon his heirs and assigns forever And lastly I the said Lewis Nabors doth hereby warrant and forever defend the aforesaid land and premises to the said Jesse Moon his heirs and assigns forever from myself my heirs and assigns and from all other persons claiming the same or any part thereof For witness whereof, I have hereunto set my hand and seal this 5<sup>th</sup> of December, Anno Domini one thousand eight hundred and forty-three.
