Know all men into that I, Tully Bolling of the State and District aforesaid, for and in consideration of the natural love and affection I have for my Daughter Abigail Maria Bolling and one Dollar to one Year, have given, granted, bargained sold and released and by these presents do release, grant, bargain sell and give to my said Daughter Abigail Maria Bolling During her natural life and after her Death to the issue of her body two tracts of Land joining each other lying in the State and District aforesaid on Mountain Creek and Saluda River, one of the tracts bought from William Morris for three hundred Acres, bounded by Allen McDavid, George Seaborn and others, as the Deed and Plat I got from Morris will show, the other tract being nearly all the tract that Micajah Perry and I bought from the Executors of John Alexander and a part of the Tract the same bought from William Berry containing three hundred and thirteen Acres, the same more or less bounded by - Williams.
