Doth Quit all manner of Claims, unto all and every part of the Above mentioned Tract of Two hundred and forty acres of Land & be the said Oliver F. Smith is to peaceably enjoy the said Tract of Land, without any Tumble or molestation, from the day of the date, Hereof for Ever. In witness whereof we the said Jane Armstrong or Jane Armstrong Jr. Julia Armstrong James Massey, Eliza Pike & John B.
