George Allison.	Acres.	sents, That I, Michael Mc Bride,

said, for and in consideration of the sum of One Hundred and Fifty Dollars, to me paid by George Allison of Charleston in the State aforesaid, have granted, conveyed, sold, and released, and by these presents, do Grant, bargain, sell, and release unto the said George Allison, Two Hundred Acres of Land, being the South East portion of that Tract containing Four Hundred and Fifty Four Acres in all, conveyed by John P. Lewis, to me, lying and being in Greenville district, and lying in Ferry's Beaver Dam Creek, a branch of the North Fork of the Saluda River, and hath such farms, and marks and bounds as is represented by a Plat of John C. Hoyt, District Surveyor, made the third day of August Eighteen Hundred and Thirtysix and attached to the Deed made by John A. Leland Superintendent of Public Works, to John P. Lewis, and then transferred by him to me, said Land being bounded on the North, by lands now or late the property of Aaron Templeman, on the East, by a Water Course, called a Creek running from Northeast to West West, or the South West by lands of Mr. Shimney, and Zach Phillips and on the West West by lands now the property of the said Michael Mc Bride said boundaries being in accordance with the aforesaid Plat which is annexed to the original Title Deed; Together with all and singular the Rights, Members, Hereditaments, and Appurtenances, to the said Premises belonging, or in any wise incident or appertaining:

To Have and to Hold all and singular the Premises before mentioned, unto the said George Allison his Heirs and Assigns, forever. And I do hereby bind myself, Heirs, Executors, and Administrators, to warrant and forever defend all and singular the said Premises, unto the said George Allison his Heirs and Assigns, against myself and my Heirs, and against every person whomsoever lawfully claiming, or to claim the same, in any part thereof.
