Know all men by these presents that I Burwell Chick of Greenville in the State of South Carolina planter, for an incideration

of the natural love & affection which I bear unto my Grand Child the heirs of Will H. M. & George Chapline, Pettus Reubin, & her further increase if she should have any and also in consideration of the sum of one dollar to me in hand by my Grand Child Pettus Reubin Chapline at & before the sealing & delivering, here by the receipt of I do hereby acknowledge hath Given Granted Sarcained and Sold & by these presents do Give, Grant, Sarcain & sell unto my Grand Child Pettus Reubin with all other increase that my daughter Will Hall Chapline may have viz. one Negro Girl Eda aged fifteen years old with her increase to have & to hold the said negro with her increase Given & Granted unto my Grand Children the heirs of my daughter Will Hall, their heirs Ex^{ts} & Administrators forever as his in their property in witness whereof I have hereunto set my hand & seal this 11th of January 1846.

Know all persons by these presents, that I, Burwell Chick of Greenville in the State of South Carolina planter for an incideration of the love & affection which I bear unto my Grand children, the heirs

of Louisa, & W. B. Farr, Burwell, James & Jane R., & her further increase if, she should have any & also in consideration of the sum of five dollars to me paid in hand by my Grand Children, Burwell James & Jane R. Farr, at & before the sealing & delivering hereof the receipt whereof I do hereby acknowledge hath Given Granted Sarcained and sold & by these presents do give Grant Sarcain & sell unto my three Grand Children Burwell James & Jane R. with all other increase that my daughter Louisa Farr may have viz. one negro man Charles, one negro Girl Nora, one negro child Semmer & one negro woman Ann, who is now at my mill, she is about thirty four years of age, the mother of Nora, to have & to hold the said Negroes
