 I, Amos Vaughan of Greenville District and
 State aforesaid in consideration of the sum
 of one hundred and fifty dollars to me in hand paid by Hannah Vaughan
 of Greenville District and State aforesaid do grant bargain sell and release
 unto the said Hannah Vaughan a certain plantation or Tract of Land
 containing one Hundred acres more or less lying in Greenville District
 on Brushy Creek of Enoree River and hath such boundaries whereas be-
 gining on a corner on the Branch where the old original line crosses
 near James Wards Spring running down sd branch to Brushy Creek
 down sd creek to John West's line thence along sd line to a post in
 the field thence along the original line to the beginning corner on the
 branch it being a part of a tract of land originally granted
 to Isaac Morgan all that here described the premises together also
 an other Tract or parcel of land containing five acres lying on sd
 waters bounded on the East side of the first described Tract of land
 and hath such boundaries whereas beginning on a stake on Raines
 line on a branch from thence down sd Branch to a stake corner
 on Raines line thence along sd line to West's Spring Branch to a
 stake thence up sd branch to a postlaw from thence a strait line
 to the beginning it being a part of a tract of land originally
