 Greenville District. } I am by these  
 presents that I Jesse Center, of the Dis-  
 trict and State aforesaid, for and in  
 consideration of the sum of One Hundred Dollars, do grant, bargain,  
 sell and release, unto H. R. Gaston of Spartanburg District, all that  
 plantation or tract of land, situated as follows - beginning on a  
 Red oak corner in Thomas Parton's land running N. 15 E. 30 cts to white  
 oak, Thence to a black oak, Parton's corner Thence E. 14 cts. to a stake  
 in the gap Creek R. Thence down the Road S. 24 E. 9 cts. 50 links to  
 a stake Thence N. 76 E. 16 cts. to a spanish oak, same course to a  
 stake on Langfords line, Thence running S. W. with Langfords, to  
 Hickory corner near the Road Oak Thence running on to Post oak,  
 Thence running on Delany's to a Chestnut corner, same course on till it  
 strike John Holcombs line a stake, Thence along the original line  
 to the Beginning corner a chestnut near old Red oak corner con-  
 taining One Hundred and Twenty acres of land, be the same more  
 or less, all and singular, the Rights, members, Hereditaments ap-  
 pertaining to the said premises, belonging or in anywise incident  
 or appertaining, To have and to hold all and singular the prem-  
 ises before mentioned unto the said H. R. Gaston his heirs Executors,  
 Administrators or assigns forever; I do hereby bind myself, my heirs  
 Executors, Administrators to warrant and forever defend, all and  
 singular the said premises unto the said H. R. Gaston his heirs,  
 & assigns against myself my heirs and every other person or per-  
 sons, whomsoever lawfully, claiming or to claim the same or any  
 part thereof. as witness my hand and seal this the fourteenth  
 day of January One Thousand Eight Hundred and forty one  
 and in the sixty sixth year of the Independence of the United  
 States of America.
