Green's Corner, & runs thence S. 30° E. 38.75 chains to a spanish Oak 3x in Spartanburg wad, thence along said road, N. 79° E. 2.70 chains - to a Large pine stump thence N. 30° E. with said S. Martins line 10 chains to a P. O. 3x, 3x - thence with said Martins line N. 85 1/2° E. 17 chains to a Black Gum in branch, John P. Shockley's corner, thence with said Shockley's line N. 52 1/2° W. 40.75 chs. to a P.
