

On the death here myself my heirs executors, administrators and assigns unto the said Peace to have and to hold all or as much of the said tract of land as the said Peace shall elect and the said George W Peace am bound to give the said Butler the third part of what is or shall be raised on the land every year after the third year from the land, the said Peace is not to give any part of the food or that shall be raised on the place

natural love and affection that I have and bear towards my daughter Caroline W Carroll now the wife of Thomas M Carroll of the same District and State aforesaid and by the consent of William West hereafter given. Have granted bargained and given and do hereby grant bargain and give to William West to and for the following to wit
That is to say Tom Wigram, Cyrus a negro boy, Martha, Becca and Harriet, Cyrus, about 14 years old, Martha 13 years, and Becca 12 years Harriet about 10 years old
The above named negroes in Trust that the said Caroline M Carroll shall have the possession, use and benefit thereof during her life and at the death of my daughter Caroline M Carroll, then to the use of the heirs of her body

Moreover the Trust is on the express condition that none of the above named negroes or their increase shall in any wise be liable for the debts or contracts of the said Thomas M Carroll within the month before the date on which he or she and full power is hereby given expressly to William West the Trustee aforesaid to take into his possession the above named negroes, Cyrus, Martha, Becca, and Harriet and to let the same for the uses above mentioned and full power is hereby expressly given to William West Trustee to demand and sue for any of the above named property whenever removed from the possession of Caroline M Carroll, without consent of either of them or if taken therefrom by Judgment, Execution or otherwise to satisfy the debts, or contracts or liabilities of the said Thomas M Carroll, as it is expressly given for the benefit above described and it is the express desire of the donor who has now is hereunto subscribed, that the Trustee enforce the Letter of this Deed
