

 James M Green of the State of South Carolina
 and District aforesaid but now a resident of

Georgia in Murray County for and in consideration of the sum of Two Hundred dollars
 to me in hand paid by Absalom Patson of the District of Greenville and
 State of South Carolina have given, granted, bargained, sold and released unto
 to him the said Absalom Patson a certain tract or parcel of land situated lying
 and being in Greenville District and State aforesaid on both sides of Reddy River
 and bounded as follows: Beginning at a pine 3x running thence S 85^o E 2 chs
 50 Lks to a water oak, thence N 8^o E 4 chains 50 links to a white oak on the bank of said
 River thence up the meander of the River to a maple corner of a seven acres formerly
 deeded to me by Daniel Simmons thence with the various courses and distances of said
 small tract to a sassafras on the bank of the River reference being had to a plat of the
 same speaking the courses and distances of the same. Thence S 23^o W 5 chs 25 links to a
 water oak, old corner thence N 59^o W 32 chs 50 Lks to a white oak old corner the
 S 70^o W 4 chs with said road to an angle in the road thence continuing with said road
 10 chains 25 Lks to a stake in the road thence S 4^o W 30 chains to a poplar on a branch
 thence down said branch following its meander a South East course 15 chs 50 links to a
 maple corner thence N 36^o E 2 chains to a sassafras thence S 50^o E 5 chs 73 links to a stake
 3x on Chumuck S 16^o W 2 chains to the Branch thence down the branch 2 chs to a maple
 thence N 65^o E 13 chs 50 links to a persimmon 3x thence N 73^o E 11 chs 50 links to a pine
 the beginning containing Two hundred Acres be the same more or less To have
 and to hold the above granted premises unto him the said Absalom Patson his
 heirs and assigns forever Together with all and singular the rights members incidents
 and appurtenances therunto belonging or in any wise incident or appertaining and I the
 said James M Green do hereby bind myself my heirs and assigns forever to warrant and
 defend the above granted premises unto him the said Absalom Patson his heirs and assigns
 against myself my heirs and assigns and against any and every other person or persons
 whatsoever claiming the same or any part thereof In Witness I have hereunto set my
 hand and affixed my seal the fifth day of August in the year of our Lord One
