 my future support of my natural life, have bargained, sold and delivered
 and do hereby bargain, sell and in plain and open market deliver unto the said
 Wm Donaldson Three Negro Children named William, age six
 years, Martha aged three years and Victoria aged eighteen months
 to have and to hold the said said and their future offspring free and increase unto
 the said Wm Donaldson his Executors, Administrators and assigns forever
 And that I the said William McCulloch, for myself my heirs Executors and
 Administrators, do covenant promise and agree to and with the said Wm
 Donaldson, that I will warrant and defend the said Slaves named William Martha
 and Victoria and their future increase unto the said Wm Donaldson his Exe-
 cutors, Administrators and assigns free and against every person whomsoever
